# Eligibility For Supplementary Benefits

- An individual must have resided in Canada as a citizen or permanent resident for at least the last 12 months immediately preceding the agreement.
- You must not be exempt from liability to pay income tax because of any other Act.
- The income eligibility is based on the net income from the previous year, as confirmed by the Canada Revenue Agency.

Adjusted net income is calculated by deducting your age (and the age of your spouse), family size, disability, and any income from the universal childcare benefit and registered disability savings plan from your net income.

Families with an adjusted net income below \$42,000 may be eligible for [MSP supplementary benefits](#).
